Fees

Application

Subject to the Three-Day Cancellation refund provision in the Enrollment Agreement, all students are required to pay a nonrefundable application fee of \$45.00 prior to enrollment. This fee is waived for spouses and dependents (with military benefits) of U.S. military servicemembers and veterans, employees of preselected corporations and postsecondary institutions with which Kaplan University has an educational relationship, Indiana residents, and preapproved student groups. Application fees are not charged to U.S. military servicemembers.

Deposits

A nonrefundable deposit of \$25.00 is required at the time of reenrollment for returning students. Once the student begins classes, the deposit will be credited to the first term's tuition. This fee is not charged to U.S. military servicemembers, Indiana residents, or Maine residents.

Technology

All students are required to pay a \$295.00 technology fee per term (\$200.00 for U.S. military servicemembers, veterans, and military spouses). For the graduate business, information technology, and education programs, MSCJ, and MSHSEM, this fee is prorated to \$150.00 per six-week term (\$100.00 for U.S. military servicemembers, veterans, and military spouses). Indiana residents receive a 10% reduction on technology fees per term.

Additional Technology Requirements for Courses

Along with the Technology Requirements listed in the Catalog, all students should review and be aware of any additional software and hardware requirements for their classes prior to enrollment. Course Assessments

A fee of \$100.00 is required for each course assessment taken.

Transcripts

A fee of \$10.00 is charged for each copy of an official transcript. A \$2.00 shipping and handling fee will be charged if the receiving school is unable to accept electronic delivery. Additional fees are as follows: notarized, \$30.00; rush delivery, \$25.00. Students will receive one free copy of their official diploma. Additional fees are as follows: duplicate/replacement, \$25.00 (free if damaged in shipment or printed with errors); notarized, \$30.00; apostille, \$100.00.

Additional Fees

A \$10.00 fee will be added for all returned checks. Refer to the Areas of Study section for program- and course-specific fees. Unless otherwise noted, these fees may be paid using financial aid funds and can be incorporated into the student's monthly payment plan.

Policies

1. Books and other instructional materials are estimated at \$50.00 to \$250.00 per course. They are not included in the cost of tuition; some courses may require students to purchase additional course materials from another source.
2. U.S. military servicemembers are not eligible for Kaplan University scholarships, tuition vouchers, or discounts. Military spouses may be eligible for a 10% reduction on standard graduate program tuition.
3. Indiana residents are not eligible for additional tuition reductions including reductions due to their employers' affiliation with Kaplan University.
4. Not all programs are available in all states. Check with an Admissions Advisor.
5. Tuition and fees are subject to change after 30 days' advance notice. See the current University Catalog/Addendum for an explanation of the Refund Policy.
6. Tuition is payable in full every term. Tuition payments can be made at the following website: kaplanuniversity.edu. Log on to KU Campus and select the "Make Payment" link.
7. Students who take courses offered by other programs within the University may be charged a different tuition rate than that for their program of study.
8. Full-time status in a graduate program is defined as 8 credit hours per term and in a nonstandard graduate program (MBA/MSA/MSF/MSIT/MSCM/MSM/MAT/MSE/MSIDT/MSHE) as 4 credit hours per term. MBA, MSA, MSIT, MSCM, MSF, MSM, graduate criminal justice and fire science, and all School of Education programs (with the exception of the Master of Science in Educational Psychology) terms are 6 weeks; all other terms are 10 weeks.
9. Failure to return library or instructional materials to Kaplan University or any of its partner libraries and resource centers will result in a financial obligation to Kaplan University and may result in postponement of registration for a new term or graduation. Instructional materials must be returned unused within 14 days from the date the student notifies the University of cancellation of enrollment. The student will be responsible for payment of any bill received for instructional materials not returned.
10. Students outside the United States or U.S. Territories will be responsible for the cost and the shipment of instructional materials including returns and payment of customs duties or fees.
11. Prior to enrollment, students enrolled in a graduate program, unless otherwise noted, must submit an unofficial transcript indicating receipt of a bachelor's degree from a college or university accredited by a regional or national accrediting agency recognized by the U.S. Department of Education. In some cases, a student's graduate degree may also be acceptable. By the last day of the first term, students must provide the University with an official copy of the transcript. If an official transcript is not submitted by the last day of the first term, the student will be withdrawn from the University and blocked from reentry, and the student's academic credentials will be withheld until such documentation is provided. Furthermore, all Title IV financial aid or any state or institutional funding must be refunded to the appropriate source, and the student will be responsible for payment of these funds to the original source or to Kaplan University.
12. **Cancellation of Enrollment Agreement:** Three-Day Cancellation—An applicant who provides written notice of cancellation within three days (excluding Saturday, Sunday, and federal and state holidays) of signing an Enrollment Agreement is entitled to a refund of all monies paid.

California Residents

The State of California created the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic losses suffered by students in educational programs who are California residents, or are enrolled in a residency program attending certain schools regulated by the Bureau for Private Postsecondary Education.

You may be eligible for STRF if you are a California resident or are enrolled in a residency program, prepaid tuition, paid STRF assessment, and suffered an economic loss as a result of any of the following:

1. The school closed before the course of instruction was completed.
2. The school's failure to pay refunds or charges on behalf of a student to a third party for license fees or any other purpose, or to provide equipment or materials for which a charge was collected within 180 days before the closure of the school.
3. The school's failure to pay or reimburse loan proceeds under a federally guaranteed student loan program as required by law or to pay or reimburse proceeds received by the school prior to closure in excess of tuition and other costs.

4. There was a material failure to comply with the Act or the Division within 30-days before the school closed or, if the material failure began earlier than 30-days prior to closure, the period determined by the Bureau.

5. An inability after diligent efforts to prosecute, prove, and collect on a judgment against the institution for a violation of the Act.

However, no claim can be paid to any student without a social security number or a taxpayer identification number. You must pay the state-imposed assessment for the Student Tuition Recovery Fund (STRF) if all of the following applies to you:

1. You are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition either by cash, guaranteed student loans, or personal loans, and
2. Your total charges are not paid by any third-party payer such as an employer, government program or other payer unless you have a separate agreement to repay the third party.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment if either of the following applies:

1. You are not a California resident, or are not enrolled in a residency program, or
2. Your total charges are paid by a third party, such as an employer, government program or other payer, and you have no separate agreement to repay the third party.

Program Fees: Students enrolled in the **Master of Science in Higher Education/Student Affairs** or **Master of Science in Educational Psychology** must have an approved criminal background check from the Kaplan University approved vendor on file prior to the first day of the first term. The fee is \$45.00 and is the responsibility of the student where applicable. **Master of Arts in Teaching–Iowa Certification Track** candidates must have an approved criminal background check from the Kaplan University approved vendor on file prior to the first day of the first term. The fee is \$75.00, is the responsibility of the student, where applicable, and is required to be paid directly to the provider. Prior to enrollment, Master of Arts in Teaching – Iowa Certification Track candidates are required to obtain a transcript analysis showing that the minimum content hours in the teaching endorsement area have been met. Kaplan University’s campus Admissions Advisor will assist the candidates in choosing an approved evaluator. Candidates will pay the transcript analysis fee directly to the evaluator, or pay through Kaplan University, depending on the chosen evaluator. The cost for each transcript analysis is \$60.00. Master of Arts in Teaching – Iowa Certification Track graduates who are recommended for full licensure will be required to pay the Iowa BoEE a licensing fee application of approximately \$85.00. **MAT-Noncertification Track** students who choose the Classroom Pathways Bundle with the American Board for Certification of Teacher Excellence Plus+ Program will pay a one-time fee of \$2,850.00 in the ninth term. Students enrolled in the **Master of Science in Educational Psychology** will pay a technology fee of \$295.00 per term during their psychology courses and \$150.00 per term during their education courses.

Students enrolled in the Master of Public Health and Master of Science in Health Education are required to pay a one-time program fee of \$300.00. This fee may be paid using financial aid funds and can be incorporated into the student's monthly payment plan. The program fees are nonrefundable and payable over the term in which the fee is billed.

Program Fees: Online students enrolled in the **Master of Science in Nursing** or a **School of Nursing certificate program** are required to submit criminal background checks. Students will be required to have an approved criminal background check from the Kaplan University approved vendor on file: (1) prior to the first day of the first term (the fee is \$44.00 and is the responsibility of the student to pay the vendor directly where applicable); (2) prior to registering for practicum or clinical courses if the original check expires prior to or during the practicum or clinical courses (the fee is \$29.00 and is the responsibility of the student where applicable).
