Standard

Tuition for Kaplan University undergraduate online programs is \$371.00 (\$315.00 for Bachelor of Science in Nursing; \$305.00 for undergraduate business and information technology students enrolled between September 17, 2011, and April 11, 2012) per quarter credit hour unless otherwise noted.

ExcelTrack™

Tuition for Kaplan University ExcelTrack programs is \$2,200 per term. These programs are not VA/TA approved. Military servicemembers and veterans are not eligible for ExcelTrack programs. Military active and veteran spouses are not eligible for military tuition reductions on ExcelTrack programs.

U.S. Military Servicemembers

For U.S. military servicemembers, tuition for Kaplan University online undergraduate degree and certificate programs is \$165.00 per quarter credit hour. U.S. military servicemembers include active duty and members of the Guard or Reserve on drill status.

Military Veterans

For military veterans, tuition for Kaplan University online undergraduate degree and certificate programs is \$230.00 per quarter credit hour (\$220.00 per quarter credit hour for Indiana residents).

Military Spouses

Military spouses are eligible for a 10% tuition reduction on the standard tuition price for undergraduate programs (with the exception of Indiana residents, who already receive a reduced tuition rate).

Indiana Residents (Nonmilitary)

Tuition for Kaplan University undergraduate online programs is \$220.00 per quarter credit hour (including Bachelor of Science in Nursing). Military personnel and populations should refer to military pricing.

Maine Online Residents (Nonmilitary)

The tuition rate is \$315.00 per quarter credit hour for the RN-to-BSN programs. Military personnel and populations refer to military pricing.

Tuition Cap

Tuition for Kaplan University undergraduate online programs is \$371.00 per quarter credit hour (\$321.00 per credit quarter hour for Maine online residents). The Kaplan University Tuition Cap is only available to first-time Kaplan University enrollees in predetermined programs, with a total cost of completion of \$22,500.00 (associate's degrees) or \$45,000.00 (bachelor's degrees). With the exception of background check and/or lab fees, tuition and fees are included in the calculation of the overall Tuition Cap program cost and will no longer be charged once the student has reached the total cost of completion.

Notice: Any questions, comments, or concerns regarding the current tuition rate and/or changes to tuition rates are to be directed to Financial Aid. Fees

Unless otherwise noted, these fees are payable directly to Kaplan University, may be paid using financial aid funds, and can be incorporated into the student's monthly payment plan.

Application

Subject to the Three-Day Cancellation refund provision in the Enrollment Agreement, all students are required to pay a nonrefundable application fee of \$45.00 prior to enrollment. This fee is waived for veterans, spouses and dependents (with military benefits) of U.S. military servicemembers, Indiana residents, employees of preselected corporations and postsecondary institutions with which Kaplan University has an educational relationship, and preapproved student groups. Application fees are not charged to U.S. military servicemembers.

Administration

All students enrolled in bachelor's and associate's degrees eligible for Kaplan University Tuition Cap pricing are required to pay a \$200.00 Tuition Cap Administration Fee per term, which covers the administration and processing of students within Cap-eligible programs.

Deposits

A nonrefundable deposit of \$25.00 is required at the time of reenrollment for returning students. Once the student begins classes, the deposit will be credited to the first term's tuition. This fee is not charged to U.S. military servicemembers, Indiana residents, or Maine residents.

ExcelTrack: Students enrolled in ExcelTrack programs are required to pay an \$895.00 tuition deposit at the time of enrollment, which will be applied toward the first term's tuition. This deposit is refundable if students cancel their enrollment or if they are cancelled by the University for not opting in to a term during the first week.

Technology

All students are required to pay a \$295.00 technology fee per term (\$200.00 for military veterans and spouses). Technology fees are not charged to U.S. military servicemembers or residents of Indiana enrolled in undergraduate programs.

Additional Technology Requirements for Courses

Along with the Technology Requirements listed in the Catalog, all students should review and be aware of any additional software and hardware requirements for their classes prior to enrollment. EL 206

Students enrolled in EL 206 will pay a \$1,500.00 course fee. This nonrefundable fee will be collected as follows: 50% after add/drop week and 50% upon submission of a portfolio for evaluation. Students who withdraw from the course after add/drop week, withdraw from Kaplan University before completing the course, fail the course, or do not submit a portfolio after completion of the course will not be charged the remaining \$750.00. This fee may be paid using financial aid funds and can be incorporated into the student's monthly payment plan.

Course Assessments

A fee of \$100.00 is required for each course assessment taken.

Transcripts

A fee of \$10.00 is charged for each copy of an official transcript. A \$2.00 shipping and handling fee will be charged if the receiving school is unable to accept electronic delivery. Additional fees are as follows: notarized, \$30.00; rush delivery, \$25.00. Students will receive one free copy of their official diploma. Additional fees are as follows: duplicate/replacement, \$25.00 (free if damaged in shipment or printed with errors); notarized, \$30.00; apostille, \$100.00.

Open College Course LRC 100

Students enrolled in the Open College@Kaplan University course LRC 100 will pay a \$1,500.00 assessment fee when they submit their portfolio for evaluation. This nonrefundable fee may be covered by financial aid.

Additional Fees

A \$25.00 fee will be added for all returned checks. Refer to the Areas of Study section for program- and course-specific fees.

Policies

1. Books

Not all courses require textbooks; some use electronic instructional materials.

Military servicemembers: Books and instructional materials are provided at no cost to U.S. military servicemembers enrolled in all undergraduate programs. Books and instructional materials are estimated at \$50.00 to \$250.00 per course.

All other students: Books and course materials are included in the price of tuition for all undergraduate courses.

2. U.S. military servicemembers are not eligible for Kaplan University scholarships, tuition vouchers, or discounts. Kaplan University is a participant in the Yellow Ribbon provision for eligible servicemembers. Spouses and dependents of eligible servicemembers who receive a transfer of benefits under the Post-9/11 GI Bill chapter 33 may be entitled to the Yellow Ribbon provision. These reductions may not be used in conjunction with scholarships or other reductions unless otherwise noted.
3. **Tuition Cap:** Enrollees in Tuition Cap programs will pay an additional \$200.00 per-term Administration Fee (which also counts toward the Tuition Cap).
Indiana Residents: Indiana residents are not eligible for Tuition Cap pricing. Enrollees in Tuition Cap programs prior to July 5, 2017, should consult with Financial Aid to determine which pricing model is most advantageous for them.
4. Not all programs are available in all states. Check with an Admissions Advisor.
5. Tuition and fees are subject to change after 30 days' advance notice. See the current University Catalog/Addendum for an explanation of the Refund Policy.
6. Tuition is payable in full every term. Tuition payments can be made at the following website: kaplanuniversity.edu. Log on to KU Campus and select the "Make Payment" link.
7. Failure to return library materials to Kaplan University or any of its partner libraries will result in a financial obligation to Kaplan University and may result in postponement of registration for a new term or graduation. Instructional materials must be returned unused within 14 days from the date the student notifies the University of cancellation of enrollment. The student will be responsible for payment of any bill received for instructional materials not returned.
8. Students outside the United States or U.S. Territories will be responsible for the cost and the shipment of instructional materials including returns and payment of customs duties or fees.
9. Upon enrollment, students must attest to high school graduation or equivalent. The University may require students to present actual proof of graduation or its equivalent as part of its verification process. If Kaplan University is required to obtain this proof of graduation on the student's behalf, there will be a \$10.00 fee charged to the student's account.
10. **Postbaccalaureate program enrollees:** Students must furnish an official transcript indicating receipt of a bachelor's degree from a college or university accredited by a regional or national accrediting agency recognized by the U.S. Department of Education by the last day of the first term. If this document is not submitted by the last day of the first term, the student will be withdrawn from the University and blocked from reentry until it is provided or the student changes his or her program of study to one that does not require proof of graduation. Furthermore, all Title IV financial aid or any state or institutional funding must be refunded to the appropriate source, and the student will be responsible for payment of these funds to the original source or to Kaplan University.
11. **Cancellation of Enrollment Agreement:** Three-Day Cancellation—An applicant who provides written notice of cancellation within three days (excluding Saturday, Sunday, and federal and state holidays) of signing an Enrollment Agreement is entitled to a refund of all monies paid.

California Residents

The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss.

Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the Fund STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment if you are not a California resident, or are not enrolled in a residency program.

It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. Questions regarding the STRF may be directed to the Bureau for Private Postsecondary Education, 2535 Capitol Oaks Drive, Suite 400, Sacramento, CA 95833, (916) 431-6959 or (888) 370-7589.

To be eligible for STRF, you must be a California resident or enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
2. You were enrolled at an institution or a location of the institution within the 120 day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued.
3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

8. A student whose loan is revived by a loan holder or debt collector after a period of non-collection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However; no claim can be paid to any student without a social security number or a taxpayer identification number.

Program Fees: Students enrolled in some undergraduate health sciences programs are required to pay a one-time program fee during initial program enrollment. The fee per program is as follows: **Bachelor of Science in Health Information Management**, \$300.00; **Medical Assistant Certificate**, \$1,050.00 (payable in three installments of \$350.00 each in the first three terms); **Medical Billing and Coding Certificate**, \$175.00; **Medical Office Administration Certificate**, \$300.00. This fee is not charged if a student re-enrolls into the same program. These fees may be paid using financial aid funds and can be incorporated into the student's monthly payment plan. The program fees are nonrefundable and payable over the term in which the fee is billed.

Students enrolled in a School of Health Sciences program that requires criminal background checks will be required to submit a request for a criminal background check to the Kaplan University approved vendor: (1) prior to the first day of the first term (the fee is \$44.00 and is the responsibility of the student to pay the vendor directly where applicable); (2) during clinical orientation if the initial background check will be more than 1 year old by the date the clinical is completed or if requested by the clinical site (the fee is \$29.00 and is the responsibility of the student where applicable).
